Dear Mr. Cahill:

It has come to our attention that you sent two letters to Iviewit without the complete correct address on 9.2.03 and we want to express that we never received such correspondences on the above mentioned cases or we would have responded sooner, prior all correspondences were correctly addressed and we are surprised that your offices did not receive them back as returned mail and contact us. None-the-less, we are responding to the issues raised in your letter in an attempt to re-open these cases and begin a formal investigation into all matters presented against these attorneys under your jurisdiction.

Your letter states that there is litigation pending that covers similar allegations and this is factually incorrect. The Florida litigation was a billing suit in which the Company submitted a Counter-Complaint that was never allowed into the proceedings and thus not a single allegation within the Counter-Complaint, civil or criminal was ever investigated or reviewed by the court. The court did not allow the Counter-Complaint in the billing case, which at the Judge's request we were to take up these other matters with State Bar Associations and Federal Authorities, which is exactly why we submitted the cases for your review of the allegations. Also, to note, is that the Florida Litigation in the billing dispute has been completed, again, not a single issue in the Counter-Complaint was heard and the case was not tried.

The Company therefore has filed a series of actions including:

- State Bar complaints in each state the attorneys practice in
- The FBI has been notified and is reviewing several of the allegations
- The Boca Raton Florida PD is investigating the case and has forwarded their case to the SEC for investigation
- The New York Attorney Generals Office has been notified
- The New York County District Attorney's Office has been notified
- The Office of Enrollment and Discipline – United States Patent & Trademark Offices have been notified
- European Patent Office & Japanese Patent Office have been notified
- The Department of Justice Anti-trust Department has been notified
- A Complaint with the SEC has been filed

Each complaint addresses varied issues, many criminal, in the conduct of these attorneys and others and we are petitioning your offices to begin an investigation into the allegations for these NY attorneys and the alleged crimes they specifically committed and we have alleged in our complaint without waiting for any other investigations outcome. Several of the other complaints include many other alleged conspirators and specific crimes committed by them and perhaps non-related to the activities of these two attorneys. Many of the complaints contain varied, separate and distinct issues that are not contained within the complaints submitted to your offices against these attorneys.

Again, due to the highly sensitive time frame of the pending patents, the shareholders of Iviewit stand to lose their investments and royalties estimated in the billions of dollars over the 20 year life of the patents and thus since these crimes alleged against these attorneys may have caused permanent damages to the patents, an investigation that clarifies these issues is needed urgently. Since several months have passed since your last correspondence addressed incorrectly and never received, the patents have may have already suffered irreparable damages caused by the Mssrs: Rubenstein & Joao.

Moreover, Joao was never involved in the Florida litigation as it was between Proskauer and Iviewit.
