Based upon our previous correspondences, please be advised that Iviewit Holdings, Inc., and in five (5) business days on the recommendation of Deborah Yarbrough, Clerk of The Florida Bar at the Supreme Court, plans to file a petition with the Supreme Court of Florida seeking, *inter alia*, a permanent injunction that stays your purported destruction of the file for the above referenced complaint, and declaratory relief for the information requested from you many times, again described below, including but not limited to:

- Nature of the position(s), including the dates of tenure, of Christopher C. Wheeler with The Florida Bar, if any;
- Nature of the position(s), including the dates of tenure, of Spencer Sax with The Florida Bar, if any;
- Proof of delivery and review of file to Chairperson of the 15(c) Grievance Committee;
- Contact information for the Chairperson of the 15(c) Grievance Committee; and
- Any correspondences or notes pertaining to complaint not since delivered Iviewit Holdings, Inc.

Moreover, you have been equally advised that the United States Patent and Trademark Office has since directed the company's patent application into a six (6) month suspension, and that the USPTO has since begun to explore the circumstances surrounding the representation of the company by Proskauer Rose LLP, and while Proskauer was acting as patent counsel.

Joao, the First Judicial Department Disciplinary Committee has filed a notice of motion to transfer those complaints based on conflicts of interest and appearances of impropriety in the response of Rubenstein's partner Steven C. Krane, a present and former member of the First Department and the New York State Bar and other conflicted ethics organizations, to the Rubenstein complaint

Accordingly, and since you have been apprised of the above events, any further action, prior to the Court's ruling, by yourself or The Florida Bar pertaining the above referenced complaint would be irresponsible and ill-advised.
