Thanks for the prompt reply but we have far more serious problems than the fee's required and were calling regarding the status of certain filings of fraud upon the EPO by our attorney's. As mentioned, the US has put our patents into suspension for 1 year while charges are investigated. We need to talk to the person who would handle such fraud charges and the patents hopefully can be suspended while similar allegations are investigated. There appears to be no sense to pay fees or answer office actions until such charges have been fully investigated and damage assessments resulting can be ascertained and either corrected or pursued for loss of rights through litigation. We appreciate if you can call us ASAP to discuss the next step before further damages and loss occur.

in response to your email yesterday concerning various patent applications, please note the following:

In proceedings before the European Patent Office (EPO) non-European applicants must be represented by a professional European representative (Art. 133(2) and Art 134 EPC). It is therefore not permitted to enter Mr. Bernstein as a contact address for these applications. Further, all correspondence should be conducted through this representative and not direct with the EPO.

In the applications mentioned by you it appears that the former representative has withdrawn his representation. You are then obliged to appoint a new representative within a 3 month period of being notified. Failure to do so will result in the relevant application being refused. I note that the address of Iviewit given in your email differs from that officially on record - I will arrange for it to be updated.
