### **Court Overhaul Begins: Attorney Disciplinary Chief Counsel Cahill First to Go...*CLICK HERE FOR FULL STORY***

Thomas J. Cahill, Chief Counsel of the First Department Attorney Disciplinary Committee, was summoned to a meeting with New York State Office of Court Administration officials on Tuesday, July 17, 2007. He was told to bring along his First Deputy Chief Counsel, Sherry K. Cohen, sources say.

The two top lawyers at the State office charged with overseeing attorney ethics in the Bronx and Manhattan sat, uncomfortably, through most of the day at various high-level conferences. In the end, it was made clear that immediate changes were being made at their Departmental Disciplinary Committee. Changes that didn't necessarily include them.

Two days later, on Thursday, July 19th, Mr. Cahill called a staff meeting where he said that he had "good news." He first announced that he had a new grandchild, and then added that he had decided to resign. He was reportedly delighted to be "... one of the few who is leaving under his own steam." Sources say he indicated that he was hoping to stay on through the end of August but was awaiting 1st Department Presiding Justice Jonathan Lippman's decision on the actual date of his final day.

On Friday, Mr. Cahill began referring to his departure as "retirement."

Tom Cahill's departure comes shortly after reporters began asking questions about an alleged cover up concerning the forced resignation of a young employee at the First Department Committee on Character and Fitness (CCF). That incident reportedly involved Mr. Cahill and Ms. Cohen at the Disciplinary Committee, and the CCF's boss Sarah Josephine Hamilton and Catherine O'Hagan Wolfe, then state Appellate Division Chief Clerk, and who is now the Chief Clerk for the federal 2nd Circuit Court of Appeals.

One insider says that the complaints against Cahill and Cohen had "...become overwhelmingly voluminous, and simply too much to continue ignoring..." The pair had been accused of selectively implementing the politically fueled and widespread practice of indefinitely delaying or white-washing certain disciplinary investigations. "Cahill and Cohen made up their own rules," according to the insider.

One such complaint involved Thomas Cahill and the Proskauer Rose law firm, and which has been "pending" since February of 2003. The Cahill Proskauer Complaint remains a troubling thorn at the highest levels of the New York State Office of Court Administration, and one which is a high priority for the new State Chief Administrative Judge, the Honorable Ann T. Pfau.

The Cahill Proskauer issue also became a hot topic in Washington, D.C. in early 2007 at the U.S. House Energy and Commerce Committee, the U.S. House Judiciary Committee and the U.S. Department of Commerce (The United States Patent and Trademark Office). And it has specifically caught the attention of U.S. Senator Dianne Feinstein, and U.S. House Representatives John D. Dingell and Nita Lowey.

The Cahill Proskauer Scandal involves many allegations: the alleged theft by Proskauer of numerous U.S. Patents from their own client; claimed losses of 17 billion dollars; and the March, 2005 bombing in Boynton Beach, Florida of the inventor-client-complainant's family mini-van.

It is alleged that Mr. Cahill masterminded the scheme to indefinitely delay complaints against Proskauer Rose, himself, and former New York State Bar Association President and Proskauer partner Steven C. Krane, Proskauer Partner Kenneth Rubenstein, chief counsel for MPEGLA, and Raymond Joao of Yonkers. It is also alleged that attorney Steven C. Krane initially interceded, with Mr. Cahill's knowledge and consent, in handling disciplinary complaints involving himself at the same time he was associated with the 1st Department in Manhattan.

Attorney Krane's conflicts were exposed when officials from the "Iviewit" company contacted Katherine O'Hagan Wolfe, who contradicted Cahill's statements and Krane's written denial of his 1st Dept roles. Ms. O'Hagan Wolfe advised that she was, in fact, on a Committee at the 1st Dept with both Cahill and Krane and that they even had a meeting that same night.

The various Cahill Proskauer issues bounced around under the public radar screen at the Court of Appeals in Albany and were ultimately transferred from the 1st Department to the 2nd Department in Brooklyn. This was done after 5 justices of the 1st Dept ruled unanimously to investigate Krane, Rubenstein and Joao for conflict of interest and the appearance of impropriety after their review of the 1st Department complaint.


The Cahill inquiry is apparently "still pending" under attorney Martin R. Gold who, insiders say, was directed to "sit on it...forever."

Earlier this year, FBI headquarters in Washington, D.C. assigned additional agents to the Public Integrity/Corruption squad at 26 Federal Plaza in Manhattan, and where agents have been actively conducting interviews.

The New York Law Journal will formally announce Mr. Cahill's departure next week.

It was only recently exposed in July that the underlying "Patentgate" inquiries were effectively buried, or derailed, under the leadership of Manhattan's top State

ethics Chief Counsel, Thomas J. Cahill, Esq. Mr. Cahill's "retirement" was then quickly announced after his own ethical failings in the Patentgate matter, along with other ethics complaints that were made, became known.

While no one can exactly figure out how inquiries under Mr. Cahill's charge went so awry, one thing is certain. At the same time the Patentgate probes were being secreted by state officials in New York, the United States Patent and Trademark Office Patent bar increased their own investigation into the same matter implicating the same attorneys. *(Note: Mr. Cahill's replacement was recently decided, and an announcement is expected as early as next week by the Appellate Division, First Department Presiding Justice, Jonathan Lippman.)*

### "Patentgate"

The defrauded company is called "Iviewit" - pronounced, "I-view-it." The company's internet site originally advertised their groundbreaking technology. Now, the opening page of the company website ([www.iviewit.tv](http://www.iviewit.tv)) displays unsettling photographs of the inventor's family vehicle after it was bombed.

"This is quite serious," says an investigator close to the federal probe. "The charges allege that valuable 'back-bone enabling digital imaging technology'-- MPEG type intellectual property-- was stolen by the inventor's own attorneys, the once-untouchable Manhattan based law firm Proskauer Rose. This is going to get very ugly," he says.

Members of the U.S. Senate and U.S. House Judiciary Committees have known about the Iviewit investigation since about September of 2006, and it is in our nation's capital where the matter quickly earned its moniker "Patentgate." And the story was also globally known in technical, Intellectual Property circles. But the big question remains: how did such an explosive story like Patentgate stay off every mainstream media's radar screen—especially in New York.

"I know how," says a retired federal agent who asked not to be identified. "Phone calls were made—many phone calls. Plain and simple." And while this retired federal agent isn't surprised by the apparent "cover-up," he is alarmed by his own findings after a month-long independent review of all submitted Iviewit papers. "I can't find one discrepancy in the allegations, not one unsubstantiated charge," he says. "For one, you have the highest state courts in New York white-washing this thing with 'unpublished' rulings. And then you have state ethics committees contradicting themselves-- in writing, no less. It's a complete meltdown," he

concludes. "The broken system appears to have finally fallen apart."

"Iviewit was been radio-active from day one," says one prosecutor who asked not to be named. "Considering who was involved, you know the phones were ringing off the hook, and with a simple directive: 'don't go near it' (an inquiry)." He believes, however that a serious shake-up is imminent. "The powers that be can't contain this story anymore—it's out, U.S. Senators and Congressman are talking about it. This involves national Commerce issues: attorneys stealing U.S. Patents from their own client, and the illegal failings of a state's ethics agency by its own cover-up, and selective, self-dealing, politically-based inaction. Patentgate appears to have exposed the true, and troubling, underbelly of ethics investigations in New York State. And its not pretty."

#### *Additional Background Information*

The original complaint involving Thomas Cahill and the Proskauer Rose law firm has been "pending" since February of 2003. The Cahill Proskauer Complaint is a high priority for the new State Chief Administrative Judge, the Honorable Ann T. Pfau.

The Cahill Proskauer issue became a hot topic in Washington, D.C. in early 2007 at the U.S. House Energy and Commerce Committee, the U.S. House Judiciary Committee and the U.S. Department of Commerce (The United States Patent and Trademark Office). And it has specifically caught the attention of U.S. Senator Dianne Feinstein, and U.S. House Representatives John D. Dingell and Nita Lowey.

The Cahill Proskauer Scandal involves many allegations: the alleged theft by Proskauer of numerous U.S. Patents from their own client; claimed losses over 10 years on a trillion dollar technology pool that has affected all forms of digital imaging and video; and the March, 2005 bombing in Boynton Beach, Florida of the inventor-client-complainant's family mini-van.

It is alleged that Mr. Cahill masterminded the scheme to indefinitely delay complaints against Proskauer Rose, himself, and former New York State Bar Association President and Proskauer partner Steven C. Krane, Proskauer Partner Kenneth Rubenstein, chief counsel for MPEGLA, and attorney Raymond Joao of Yonkers. It is also alleged that attorney Steven C. Krane initially interceded, with Mr. Cahill's knowledge and consent, in handling disciplinary complaints involving himself at the same time he was associated with the 1st Department in Manhattan.

Attorney Krane's conflicts were exposed when officials from the Iviewit company

contacted Katherine O'Hagan Wolfe, who contradicted Cahill's statements and Krane's written denial of his 1st Dept roles. Ms. O'Hagan Wolfe advised that she was, in fact, on a Committee at the 1st Dept with both Cahill and Krane, and that they even had a meeting that same night.

The various Cahill Proskauer issues bounced around under the public radar screen at the Court of Appeals in Albany and were ultimately transferred from the 1st Department to the 2nd Department in Brooklyn. This was done after 5 justices of the 1st Dept ruled unanimously to investigate Krane, Rubenstein and Joao for conflict of interest and the appearance of impropriety after their review of the 1st Department complaint.

The Cahill inquiry is apparently "still pending" under attorney Martin R. Gold who, insiders say, was directed to "sit on it...forever."

Earlier this year, FBI headquarters in Washington, D.C. assigned additional agents to the Public Integrity Corruption squad at 26 Federal Plaza in Manhattan, and where agents have been actively conducting interviews.

### Ethics Scandal Hearing Greeted With \$1.5 Billion Dollar Lawsuit (*MORE, CLICK HERE*)

#### Tammany Hall II, Public Corruption Scandal Grows - by \$1.5 Billion

A federal court-ordered hearing in the New York State Ethics Scandal Case (*Anderson v. State of New York 07cv 9599*) was held in Courtroom 15C of the United States Courthouse at 500 Pearl Street in Manhattan on Wednesday, December 12, 2007 before U.S. District Court Judge Shira A. Scheindlin.

Numerous reports confirm the hearing quickly turned extraordinary.

Federal Judge Scheindlin first read into the record a list of 8 different people from around the world who had copied the court on various correspondence concerning the New York Ethics Scandal and their support for the appointment of a federal monitor.

An author of one of the letters, P. Stephen Lamont of Iviewit, immediately advised the court that he was withdrawing his copying of his letter to the court in light of an associated federal complaint filed shortly before the hearing.

A court law clerk then handed Judge Scheindlin a copy of the just-filed complaint, *Bernstein v. 1st Dept. Disciplinary Committee, et al.* (S.D.N.Y 07cv 11196, filed December 12, 2007)

⋮ Re: U.S. Department of Justice

The \$1.5 Billion Dollar Bernstein complaint alleges widespread public corruption in the handling of ethics complaints involving fraud and stolen U.S Patents by various New York law firms and attorneys. The action by Bernstein has been marked as an associated case to the *Anderson* lawsuit since both matters concern allegations of Ethics Committee Public Corruption and, additionally, both cases seek the appointment of a federal monitor over New York State ethics committees.

Bernstein's allegations, and known as "Patentgate" are currently under review by numerous U.S. Senators, the U.S. Congress, the United States Patent and Trademark Office and the FBI's watchdog unit, the Office of Professional Responsibility in Washington, D.C.


The defense counsel in the *Anderson* matter, a Lee Alan Adlerstein from the New York State Attorney General's office, attempted to categorize the Anderson case as a simple wrongful termination action, but the Judge did not see it that way-- and said so.

"This case is not a garden variety...it's a *whistleblower*...there is that aspect to it...," said Judge Scheindlin.

Informed sources reveal that at least one more associated federal complaint will be filed soon, along with other various filings that will pull together serious allegations of ethics related public corruption from every corner of New York State.

### NY Federal Judge: Ethics Scandal Cases Related

On Thursday, January 10, 2008, U.S. Federal District Court Judge Shira A. Scheindlin directed that the 1.5 Billion dollar Iviewit "patentgate" case, filed in the U.S. District Court for the Southern District of New York on December 12, 2007, be assigned to her court.

Judge Scheindlin accepted the Iviewit lawsuit, *Bernstein v. Appellate Division First Department Departmental Disciplinary Committee*, as related to the pending New York attorney ethics scandal case, *Anderson v. The State of New York*.

Allegations of covering-up and whitewashing complaints against favored attorneys find both cases seeking the appointment of a federal monitor to take over New York's statewide attorney ethics committees. ### Federal Judge on DDC Ethics Scandal: "Whistleblower"

The federal court transcript of the December 12, 2007 hearing in Tammany Hall II - New York's newest Ethics Scandal has been obtained, and is posted to the right, "Ethics Scandal Update: February 7, 2008".

The hearing before U.S. Federal District Court Judge Shira A. Scheindlin preceded the two now-approved as related cases in the New York attorney ethics scandal. The 3rd case, entered Monday, January 14, 2008, is Esposito v. The State of New York. (SDNY 07cv11612) The Esposito case joins Anderson v. The State of New York, which unearthed the apparent long-held practice of cover-ups and whitewashing of complaints against favored attorneys at the Manhattan based attorney Departmental Disciplinary Committee.

The Esposito ruling followed the January 11, 2008 announcement that a 2nd case, the 1.5 Billion dollar Iviewit lawsuit, known throughout the world in technical, intellectual property circles as "Patentgate," had also been ruled by Judge Scheindlin as related to the Ethics Scandal. (SDNY Bernstein v. Appellate Division First Department Departmental Disciplinary Committee)


Other filings seeking to be designated by Judge Scheindlin as 'related' to the ethics scandal matter are expected soon.

**NY Ethics Scandal Tied to International Espionage Scheme (MORE, CLICK HERE)**

### **Tammany Hall II Ethics Scandal Reaching New Heights**

Reports surfaced in New York and around Washington, D.C. last week detailing a massive communications satellite espionage scheme involving major multi-national corporations and the interception of top-secret satellite signals.

The evidence in the corporate eavesdropping cover-up "is frightening," according to an informed source who has reviewed the volumes of documentation. The espionage scheme, he says, is directly tied to the growing state bar ethics scandal at the Appellate Division First Department, Departmental Disciplinary Committee (DDC) in Manhattan.

**Rumors had been Circulating Linking the NY Bar Scandal to International Corporate Espionage Ops Using Satellites**

The highflying spy operation involves private and public companies, mainly in the U.S. and Europe, that operate apart- but not too far- from national intelligence services. Confidential sources have learned that the original source of much of the secret information comes from satellite intercepts sold by telecom companies under contract to government spy agencies.

Although it's rarely addressed in any official proceedings, basically all private telephone conversations and email transmissions in the U.S., and essentially worldwide, are routinely intercepted by one government authority or another. Much of the work is done by independent telecom companies that transmit the signals on to giant computers that translate the text in real time. This instant translation capability put an end to many embarrassing backlogs, as in the case of the first World Trade Center bombing, where the FBI had received an intercept, but hadn't translated the key incriminating conversation before that 1993 event.

Once translated, the reviewing super computers search for key words to flag suspect conversations and transmissions. Proper names of people, buildings, addresses, codes, arms, explosives and the like will trip a full-scale investigation of a transcript.

Apart from the official surveillance of signal intelligence (or "sigint" in the spy trade), what confidential sources have discovered is that there is lots of freelance spying going on, where top-secret corporate information is being offered for sale to the highest bidder. The payments are allegedly made for a tip of such secrets as planned corporate acquisitions, mergers, or some very positive or negative performance reports.

Advance knowledge of corporate information, and the corresponding improper company stock activity, has long been the focus of many insider trading investigations but has not, until now, directly involved New York City's attorney ethics committee. One source says it's been the 'perfect crime.' "The brains behind this organized scheme have thwarted attorney ethics investigations in New York, federal criminal inquiries and various civil actions around the country by simply citing 'national security,'" says the source.

**Enter the DDC, again**

Since this secret corporate information is sent across public telecom networks that are constantly subject to interception, the black market in top-secret corporate intel continues to grow, and it generally evades detection. Last week, however, investigators tripped across evidence of a law firm protecting a client that had been on the selling side of corporate espionage. When complaints were filed with the New York Attorney Disciplinary Committee against the firm for a series of ethical violations, those grievances apparently disappeared into one of the now-well-known DDC black holes.


Another trusted source from outside New York has indicated that federal court

Federal Judge: "But you destroyed the faith of the people in their government."

Worthy of Review is the Posting from Super Bowl Sunday, February 3, 2008:

**Federal Judge Michael Mills: "But you destroyed the faith of the people in their government."**

It takes a little longer for a big city investigation to come to light than it would in a smaller locale. But in addition to being patient, New Yorkers should be encouraged by the recent words of Federal U.S. District Court Judge Michael Mills, notably this Super Bowl day from the town that brought New York Eli Manning-Oxford, Mississippi. There are many issues common to little Oxford, Mississippi and big New York, New York: a need for federal intervention over state corruption; conspiracy; public corruption; and the destruction of the faith people have in their government.

### Nowlin to serve thirty months in prison

Despite numerous letters from prominent community members and a glowing report of cooperation from the U.S. Attorney's Office, insurance agent Ken Nowlin was sentenced Thursday to spend 30 months behind bars in a federal prison for

conspiracy.

Nowlin was charged in June with conspiracy for paying former Lafayette County Supervisor Gary Massey a "commission" during Massey's term as supervisor.

In late July Nowlin pleaded guilty to the charge and had been awaiting his sentencing hearing which was held Thursday afternoon at the Federal Courthouse in Oxford before U.S. District Judge Michael Mills. The Ecrú insurance agent told Mills he was sorry for his actions.

"I'd like to apologize to you, Judge (Glen H.) Davidson, the court, Lafayette County, my family and colleagues," Nowlin said before the judge. "I'm sorry I made this terrible mistake ... I know I broke the law ... Somehow I was misled."

"Who misled you?" Mills asked.

"An elected official, your honor," Nowlin replied.

U.S. Assistant Attorney Dave Sanders told Mills that Nowlin has fully cooperated with the investigation by supplying documents and testifying before a grand jury against Massey.

"Mr. Nowlin has met with us on several occasions and sat down and clarified some things," Sanders said. "It's a complicated case and he's always been cooperative."

According to the Federal Sentencing Guidelines, Nowlin faced up to 30 months in prison. The U.S. Attorney's Office filed a motion for downward departure in Nowlin's favor, asking the court to consider a sentence less than the guidelines stipulate since Nowlin was so cooperative.

But despite the request and his cooperation, Mills sentenced Nowlin to the maximum sentence of 30 months.

"Up until this offense your record was exemplary," Mills said to Nowlin. "I've received many letters from some impressive people on your behalf ... But you destroyed the faith of the people in their government."

Nowlin was also sentenced to pay \$275,942 in restitution back to Lafayette County. Nowlin's attorney, Tony Farese, told Mills that Nowlin had already paid the full restitution on Tuesday.

Mills allowed Nowlin to remain out of custody on bail until March 31 when he will have to report to a prison facility that will be determined at a later date.

Massey and Nowlin were originally charged in June for conspiracy, public corruption and money laundering in a 53-count indictment, which alleged Massey accepted payments in excess of \$827,000 during his term as supervisor from 1996 - 2003, for the Lafayette County Employee Health Care Contract paid through Nowlin, the agent of record at the time.

Massey pleaded guilty in September to one count of conspiracy and two counts of public corruption. He is still awaiting a sentencing date.

Sanders announced during Thursday's hearing that the remaining 52 counts against Nowlin will be dropped by the U.S. Attorney's Office.

Before he became a supervisor in 1995, Massey was the insurance agent of record for Lafayette County. Federal prosecutors claim Massey used his influence to get Nowlin the job as insurance agent of record in exchange for the commission.

Prosecutors said Nowlin would receive payment for services in two checks made out to his office from plan administrator Total Plan Services. Nowlin took the checks and told his office to write a separate one to Massey for a "consulting fee."

### Feds Summon Court Corruption Members to Washington, D.C.

*by Franklin N. Brady - December 3, 2008*


NEW YORK- Incontrovertible evidence that federal crimes have been committed in and about New York's federal and state courts has resulted in the scheduling of meetings this week with various Congressional Committees charged with oversight. While the New York criminal conduct that would come under review by the various federal agencies has been discussed for years, the October 2007 filing of [Anderson v. The State of New York, et al., 07Civ9599](#), in the United States District Court for the Southern District of New York brought increased interest. The review by federal committees involving New York's "Ethics Scandal" quickly caught the eye of officials in Washington, D.C. when nine (9) related federal cases, with similar allegations, followed the Anderson insider filings. Formal requests have been made to hold public hearings with a view toward the eventual oversight of the New York State Court System by a federal monitor.

In one meeting held in Washington, D.C. on Monday, December 1, 2008, an attorney, and Washington, D.C. insider, was quoted as saying that, "New York's about to be rocked." The D.C. meeting was attended by members of the New York based group, *Integrity in the Courts*. One participant quoted the current Chairman of Manhattan's Departmental Disciplinary Committee, Roy I. Reardon, as saying that New York's judges belong to one of three categories: "one third are decent, honest and hardworking... another third aren't very smart.... and one third are

corrupt...” While Mr. Reardon enjoys a reputation of high integrity, it is generally believed that he was wronged by his appointment as captain to a flame-engulfed sinking ship, the Manhattan-based attorney ethics committee.

Another specific request has been made to have the federal government take over the New York State Commission on Judicial Conduct, a group known for its widespread corruption in handling ethics matters over the state’s judges. P. Stephen Lamont, Chief Executive Officer of Iviewit Holdings, Inc., and one of the nine post-Anderson federal actions, has confirmed that his attendance was requested at meetings on Capitol Hill. He expects to make a formal statement before the end of the month. It has also been confirmed that the ‘Ethics Insider,’ New York attorney Christine C. Anderson, has been requested to attend the federal oversight committee meetings, as well as at least two New York State judges who are expected to participate via video-conference. “Washington recognizes that the issues raised do not pertain to a single case or group of related cases, but rather to a systemic cause of concern in the State of New York,” said one member, “The [Anderson case](#) has solidified the documented and countless examples of the violations of federal law requiring appropriate committee review.”

### Proskauer Rose 'House of Cards' Crumbling

#### Proskauer lays off 35 associates and 25 staff

*Legal Week by Zach Lowe - December 5, 2008*

Proskauer Rose is laying off 35 associates and 25 administrative staff, reports The Am Law Daily. The news was announced in a memo, sent out by the firm yesterday (4 December), although which offices or practice areas will suffer the most is not specified. The New York firm said the layoffs are due to both the economic crisis and the "unprecedented reduction in our historical lawyer attrition rate."

Proskauer launched an office in London last year with hire of Matthew Hudson, the former head of O'Melveny & Myers' City arm. In September, the firm also secured its long-awaited Asia launch after hiring a two-partner team in Beijing from Heller Ehrman. Proskauer has been one of the most upwardly-mobile practices in the US in recent years, successfully expanding beyond its core employment practice into a stronger corporate profile. During the last two weeks a raft of US firms have made layoffs, including Reed Smith, White & Case, Orrick Herrington & Sutcliffe, while firms including Cravath Swaine & Moore and Simpson Thacher & Bartlett have cut back associate bonuses.

In a letter dated July 16, 2007, the U.S. Department of Justice, Office of Professional Responsibility, announced from its Washington, D.C. headquarters

that it was expanding its investigation into a bizarrely stalled FBI investigation that involves an almost surreal story of the theft of nearly 30 U.S. Patents, and other intellectual property, worth billions of dollars. The probe reaches some of New York's most prominent politicians and judges, and has already proven to be a stunning embarrassment to the State's ethics watchdog committees. ## The Fox and the Hen House

It was only recently exposed in July that the underlying "Patentgate" inquiries were effectively buried, or derailed, under the leadership of Manhattan's top State ethics Chief Counsel, Thomas J. Cahill, Esq. Mr. Cahill's "retirement" was then quickly announced after his own ethical failings in the Patentgate matter, along with other ethics complaints that were made, became known.

While no one can exactly figure out how inquiries under Mr. Cahill's charge went so awry, one thing is certain. At the same time the Patentgate probes were being secreted by state officials in New York, the United States Patent and Trademark Office Patent bar increased their own investigation into the same matter implicating the same attorneys. (Note: Mr. Cahill's replacement was recently decided, and an announcement is expected as early as next week by the Appellate Division, First Department Presiding Justice, Jonathan Lippman.)

## "Patentgate"

The defrauded company is called "Iviewit" - pronounced, "I-view-it." The company's internet site originally advertised their groundbreaking technology. Now, the opening page of the company website ([www.iviewit.tv](http://www.iviewit.tv)) displays unsettling photographs of the inventor's family vehicle after it was bombed.

"This is quite serious," says an investigator close to the federal probe. "The charges allege that valuable 'back-bone enabling digital imaging technology'-- MPEG type intellectual property-- was stolen by the inventor's own attorneys, the once-untouchable Manhattan based law firm Proskauer Rose. This is going to get very ugly," he says.

Members of the U.S. Senate and U.S. House Judiciary Committees have known about the Iviewit investigation since about September of 2006, and it is in our nation's capital where the matter quickly earned its moniker "Patentgate." And the story was also globally known in technical, Intellectual Property circles. But the big question remains: how did such an explosive story like Patentgate stay off

every mainstream media's radar screen—especially in New York.

"I know how," says a retired federal agent who asked not to be identified. "Phone calls were made—many phone calls. Plain and simple." And while this retired federal agent isn't surprised by the apparent "cover-up," he is alarmed by his own findings after a month-long independent review of all submitted Iviewit papers. "I can't find one discrepancy in the allegations, not one unsubstantiated charge," he says. "For one, you have the highest state courts in New York white-washing this thing with 'unpublished' rulings. And then you have state ethics committees contradicting themselves-- in writing, no less. It's a complete meltdown," he concludes. "The broken system appears to have finally fallen apart."

"Iviewit was been radio-active from day one," says one prosecutor who asked not to be named. "Considering who was involved, you know the phones were ringing off the hook, and with a simple directive: 'don't go near it' (an inquiry)." He believes, however that a serious shake-up is imminent. "The powers that be can't contain this story anymore—it's out, U.S. Senators and Congressman are talking about it. This involves national Commerce issues: attorneys stealing U.S. Patents from their own client, and the illegal failings of a state's ethics agency by its own cover-up, and selective, self-dealing, politically-based inaction. Patentgate appears to have exposed the true, and troubling, underbelly of ethics investigations in New York State. And its not pretty."

## Additional Background Information

The original complaint involving Thomas Cahill and the Proskauer Rose law firm has been "pending" since February of 2004. The Cahill Proskauer Complaint is a high priority for the new State Chief Administrative Judge, the Honorable Ann T. Pfau.


The Cahill Proskauer issue became a hot topic in Washington, D.C. in early 2007 at the U.S. House Energy and Commerce Committee, the U.S. House Judiciary Committee and the U.S. Department of Commerce (The United States Patent and Trademark Office). And it has specifically caught the attention of U.S. Senator Dianne Feinstein, and U.S. House Representatives John D. Dingell and Nita Lowey. The Cahill Proskauer Scandal involves many allegations: the alleged theft by Proskauer of numerous U.S. Patents from their own client; claimed losses over 10 years on a trillion dollar technology pool that has affected all forms of digital imaging and video; and the March, 2005 bombing in Boynton Beach, Florida of the inventor-client-complainant's family mini-van.

Judicial Advertising

It is alleged that Mr. Cahill masterminded the scheme to indefinitely delay complaints against Proskauer Rose, himself, and former New York State Bar Association President and Proskauer partner Steven C. Krane, Proskauer Partner Kenneth Rubenstein, chief counsel for MPEGLA, and attorney Raymond Joao of Yonkers. It is also alleged that attorney Steven C. Krane initially interceded, with Mr. Cahill's knowledge and consent, in handling disciplinary complaints involving himself at the same time he was associated with the 1st Department in Manhattan. Attorney Krane's conflicts were exposed when officials from the Ivewit company contacted Katherine O'Hagan Wolfe, who contradicted Cahill's statements and Krane's written denial of his 1st Dept roles. Ms. O'Hagan Wolfe advised that she was, in fact, on a Committee at the 1st Dept with both Cahill and Krane, and that they even had a meeting that same night.

The various Cahill Proskauer issues bounced around under the public radar screen at the Court of Appeals in Albany and were ultimately transferred from the 1st Department to the 2nd Department in Brooklyn. This was done after 5 justices of the 1st Dept ruled unanimously to investigate Krane, Rubenstein and Joao for conflict of interest and the appearance of impropriety after their review of the 1st Department complaint. The Cahill inquiry is apparently "still pending" under attorney Martin R. Gold who, insiders say, was directed to "sit on it...forever." Earlier this year, FBI headquarters in Washington, D.C. assigned additional agents to the Public Integrity Corruption squad at 26 Federal Plaza in Manhattan, and where agents have been actively conducting interviews.
