Re: EMPLOYMENT TERMINATION & RETURN OF PROPERTY

Dear Mr. Lamont:

I regret the decision to terminate your employment but in the best interests of the Iviewit shareholders such action must be executed. Due to the serious nature of the admitted false statements regarding your introduction to the company in the April 2004 shareholder communication (circulated to several hundred people) regarding your involvement with Microsoft, the company must now notify the shareholders that you are changing your statements claiming you did not have conversations with Microsoft regarding Iviewit.

Also, other areas of concern are: (i) the recent statements to Candice Bernstein with your involvement with Ted Leonsis's niece and then later stating that you were lying, (ii) your statements regarding the events with Kenneth Rubenstein, (iii) the false statement that someone had shot a bullet through your home window prompting both Candice and myself to contact the Westchester police to identify the evidences you stated were collected by the police and where I then contacted our source at the FBI with similarly false information. Only after being contacted by the police on a three way call with Candice and I, did you recant such fabricated story claiming you had lied and really called you aunt who was connected to the mafia in New York, (iv) the recent refusal to submit the company references to verify your background for the United States Supreme Court filling, (v) conversations with Chuck Brunelas wherein he stated he could not testify to the background information you had prior at the website and that he had no knowledge of your statements contained in the shareholder letter stating you were planted by Microsoft when he recruited you, and, (vi) your recent missing of a

These actions all represent risks that at first we tried to understand due to the stress of losing your wife last year but this pattern of deceit now represents risks that cannot be tolerated. As of this point forward, please make no further representations for the companies and immediately return all properties to the company, including hardware, software, mail, correspondence of any sorts, all taped conversations and any other items you may possess. Failure to provide these items will result in the company taking action with the proper authorities, as you know the materials are all evidentiary in ongoing investigations.

Again, I regret such actions on behalf of the companies and we wish you well in your forward endeavors.
