Re: Iviewit Patent Attorney Investigations

Dear Mr. Mercer,

I am in receipt of your letter dated November 18th 2005 and let me please clarify a few issues with the letter. First, I am not a lawyer and thus no title of esquire is appropriate. I am one of the Iviewit inventors and founder of the companies that have been wronged by our lawyers. Several errors may be present in your analysis and I just want to clarify these issues as they are critical to a thorough investigation. It appears that you are only investigating one lawyer, Martyn Molyneaux, and one law firm Harrison, Goddard and Foote. Mr. Molyneaux is only one of the EPO attorneys involved in the filing of the Iviewit patents over their respective histories. Mr. Molyneaux was also involved with the Wildman Harrold Allen & Dixon law firm over the course of his representation and I was wondering if both his firms would be fully investigated.

Most important is that Iviewit was represented by several other EPO legal representatives that were initially retained by the law firms of Foley and Lardner and Meltzer Lippe Goldstein Wolfe & Schlissel to file the foreign filings. I am not sure who filed these originally on behalf of our companies and the law firms have refused disclosure here in the United States and Molyneaux was unable to provide that information as well. I therefore turned to the EPO and Liza Dybdahl and Prof. Alain Pompidou to ascertain the complete filings which would reveal those involved and in attempting to gain these files I have been refused. In a recent letter from Dybdahl she referred me to the website filings which again do not contain the legal representatives that filed these patents and worked on them, so that they may be investigated and prosecuted similar to Molyneaux. I merely seek complete and certified copies of these patents and all documents that have been filed

on my companies' behalf and this is kept out of reach by the EPO. All attorneys that are licensed before the EPO that were involved in these patents must be investigated, no matter how miniscule their part has been. This information must be made available to me to fully have all of them prosecuted properly.

I also was under the impression that Prof. Alain Pompidou, President EPO, and Mrs. Liza Dybdahl were licensed to practice before the EPO, as well maintaining their respective jobs with the EPO. If so, would they also been under your jurisdiction to investigate if their actions have led to a loss of patent rights, which it appears that their inactions may have led to already? If not, who would their actions be properly reported to and challenged?

I fully understand the issues regarding the United States attorneys being outside your jurisdiction. I remain confused as to how the original Patent Cooperation Treaty filings are treated and who investigates those attorneys under that treatise. Are you involved in that process of prosecuting the attorneys that filed fraudulently the PCT applications, please clarify.
