Eliot,

We remind you of the deadlines to file a written response in Europe for the following patent applications:

P011EP - 2 August 2003
P010EP - 10 August 2003

Because at least a two month extension of time to respond has already been taken on each of these cases, the European examiner will most likely NOT grant any further formal extensions. However, we may still be able to effectively delay the filing of a complete response, should the examiner give us another chance (and will most likely charge an additional processing fee). As you know, a failure to respond timely will result in the applications being withdrawn/abandoned.

As you are also aware, we do need to have the estimated payments in advance of doing the work. We also need at least a few days to prepare the draft instructions, and then another few days for our foreign associate to prepare and file the actual response.

Accordingly, we need your instructions and payment at least a week before the deadlines stated above.
