Title

Alleged Murder of Simon Bernstein & Arrest of Kimberly Moran for Fraud and Admitted Forgery in Estate Documents filed, Judge Martin Colin threatens Miranda Warnings to Attorneys Robert Spallina & Donald Tescher

Sub Title

Judge Martin Colin of the Florida Probate court, issued warnings to Attorneys at Law Spallina & Tescher for filing documents in Simon Bernstein's name to close his wife's estate, months after he was deceased

Body

Simon Bernstein died on September 13, 2012. Immediately following his death, Simon's son Theodore "Ted" Stuart Bernstein, contacted the Palm Beach County Sheriff's office to report a possible murder of his father, claiming that Simon's companion, Maritza Puccio, had murdered Simon through poisoning, as alleged in the Palm Beach County Sheriff report, No. 12121312. That on September 13, 2013 Ted also ordered an autopsy, Case No. 12-093 of his father for his suspicion that his father was murdered, which was performed by Michael D. Bell, M.D. District Medical Examiner.

That on September 13, 2013, in a hearing before the Hon. Judge Colin, it was learned that documents submitted to close the estate of Simon's predeceased wife, Shirley Bernstein, were submitted fraudulently to that court to close the estate of Shirley by Simon, months after his death, submitted as if he were alive and whereby the Attorneys at Law Robert Spallina and Donald Tescher failed to notify the court that they were closing the estate with a dead man's documents filed as if he were alive.

Further, after complaints were filed by Simon's other son, world renowned inventor of digital scaling techniques, Eliot Ivan Bernstein, with the Palm Beach County Sheriff and the Governor Rick Scott's Notary Public division, a one Kimberly Moran, legal assistant/notary public for the law firm of Tescher & Spallina, P.A., admitted to Detective Ryan Miller of the Palm Beach County Sheriff's office that she had "traced" aka forged and fraudulently notarized documents for six members of the Bernstein family, Ted Bernstein, Pamela Simon, Eliot Bernstein, Jill Iantoni, Lisa Friedstein and the deceased Simon Bernstein, in the estate of Shirley Bernstein, leading to the Judge Colin reopening Shirley's estate. For a complete statement by Moran, see Palm Beach County Sheriff office arrest report No. 13097087 where Moran admits to felony crimes. That Moran's notary license was subsequently revoked by Governor Rick Scott of Florida after investigation by Erin Tupper of that office.

That after learning that documents were filed in Simon's name, as if he were alive, to close Shirley's estate and a fraud on the court had occurred, Judge Colin stated to Attorneys at Law Spallina, Tescher and Mark Manceri and Ted,

That in these court filings Eliot Bernstein has alleged that Ted and his sister Pamela Simon, who were disinherited from their parents estates, worked together in conspiracy with Ted’s close personal friends and business associates, Attorneys at Law Tescher and Spallina, in efforts to force Simon to change the beneficiaries of the estates of he and Shirley prior to his death to include them back in and when that failed and Simon then mysteriously and suddenly died, they made the changes for Simon POST MORTEM using his identity after he died to change the estate beneficiaries of Shirley and Simon through a series of documents, including an alleged improperly notarized and witnessed Will and Amended and Restated Trust of Simon, to illegally seize Dominion and Control of the estates and begin a looting of the estate through a plethora of alleged criminal acts.

That Eliot has alleged further fraudulent activity in an attempt by Ted and Pamela, again in conjunction with Robert Spallina, to abscond with a life insurance policy worth millions on the life of Simon through a series of alleged fraudulent activity, including but not limited to, fraud on a US District Court and Insurance Fraud. The initial claim filed for the policy by Robert Spallina, acting as Trustee of what he claims is a lost trust was denied by the carrier, Heritage Union Life Insurance Company. When that failed, Ted suddenly claimed that he was now “Trustee” of the lost trust and filed a federal Breach of Contract lawsuit, in Case No. 1 :13-cv-03643 in the United States District Court Northern District of Illinois titled “Simon Bernstein Irrevocable Insurance Trust Dtd 6/21/95 v. Heritage Union Life Insurance” before the Honorable Judge Amy J . St. Eve and Magistrate Mary M. Rowland and was subsequently counter sued by Jackson National Life and Eliot. Eliot has also alleged, as exhibited in Petition 1 above, that these alleged crimes in the estate of Simon may be tied to a series of crimes alleged to have been committed by Attorneys at Law, primarily from the law firms of Proskauer Rose and Foley & Lardner, to steal Intellectual Properties valued in the Billions to Trillions of dollars, coined as “Digital Electricity” and the “Holy Grail” of the Internet, these technologies resolved the problem of pixilation on images for unlimited zoom and pan on low resolution images and are the key backbone technologies to Internet and low bandwidth video communications. That Simon (30% owner) and Eliot (70% owner) started a series of companies known as Iviewit and filed a series of Patents, Trademarks, Copyrights and Trade Secrets and information regarding these
