CURATOR'S MOTION FOR AUTHORIZATION

COMES NOW, Curator, Benjamin P. Brown ("Curator"), by and through undersigned counsel, files this Motion for Authorization and states as follows:

- 1. On February 25, 2014, this Court entered an Order on "Interested Person" William Stansbury's Motion for the Appointment of a Curator or Successor Personal Representative ("Order Appointing Curator"), appointing Benjamin P. Brown as Curator of the Estate of Simon L. Bernstein (the "Estate"). On March 11, 2014, this Court entered Letters of Curatorship in Favor of Benjamin Brown ("Letters of Curatorship").
- 2. In order for the Decedent's revocable trust, the Simon Bernstein Trust (the "Trust"), to be included as part of his Estate for tax purposes, a Form 8855 ("Election to Treat a Qualified Revocable Trust as Part of an Estate") must be completed by the an Estate representative and the Trustee of the Trust. A copy of the Form 8855 to be completed is attached hereto as Exhibit A.
- 3. Form 8855 allows the Trust to file its tax return within the time frame that the Estate must file its own, rather than the shorter time period generally required for trusts. In addition, Form 8855 allows the Estate to potentially take advantage of certain tax deductions that would otherwise be unavailable to it.

4. The Internal Revenue Service requires that Form 8855 be filed by the due

date of Form 1041 (Income Tax Return for Estates and Trusts) for the first tax year of the

Estate. That due date is May 15, 2014.

5. Accordingly, this is to request that the Court authorize the Curator to

execute Form 8855.

WHEREFORE, the Curator respectfully requests that this Court enter an Order

authorizing the Curator to execute the Form 8855 attached hereto as Exhibit A, and for

such other relief as the Court deems just and proper.
