ORDER ON SECOND PETITION FOR PAYMENT OF CURATOR'S FEE

THIS MATTER came before the Court on the Second Petition for Payment of Curator's Fee dated May 16, 2014 ("Petition"), and the Court having reviewed the pleadings, the parties having agreed on the form of this Order, and being otherwise fully advised in the premises, it is hereby ORDERED AND ADJUDGED that said Petition is GRANTED. The Court finds and holds as follows:

1. that Curator has reasonably expended 29.70 hours in attorney and paralegal time to perform the services set forth in the Petition for the period addressed by the Petition, and that \$234.43 is a reasonable average hourly rate for the type of services provided;
2. that Curator is hereby awarded \$6,962.50 as a reasonable fee for the services set forth in the Petition for the period addressed by the Petition;
3. that Curator has advanced costs on behalf of the Estate in the total amount of \$224.40, which were reasonable and necessary costs expended in connection with and in furtherance of the Curator's performance of said services and for which Curator is entitled to be reimbursed;

4. that Curator is entitled to a total award of fees and costs of \$7,186.90, which amount is a Class 1 obligation of the Estate pursuant to Florida Statutes §733.707(1)(a); and
5. that Curator is authorized and directed to pay the amount of \$7,186.90 to Matwiczuk & Brown, LLP, from the assets of the estate.
