#### FOURTH PETITION FOR PAYMENT OF CURATOR'S FEE

COMES NOW, Benjamin P. Brown, Esq., Curator ("Curator") of the Estate of Simon L. Bernstein, and requests that the Court enter an Order authorizing payment of Curator's fees and shows unto the Court as follows:

- 1. On February 25, 2014, this Court entered an Order on William Stansbury's Motion for the Appointment of a Curator or Successor Personal Representative, and on March 11, 2014, this Court issued Letters of Curatorship in favor of Benjamin Brown.
- 2. The Curator has rendered services and incurred expenses for the benefit of the Estate for the period June 1, 2014 through June 30, 2014 as set forth in the itemized summary of services and expenses attached as Exhibit A, for which the Curator has not been paid. The fees owed are \$15,382.50. The costs owed are \$1,398.96 for a total due in the amount of \$16,781.46. The total amounts paid/owed to the Curator are depicted on Exhibit B attached hereto.
- 3. The Curator's fees and costs described on the attached Exhibit A were incurred in discharging administration responsibilities. Such responsibilities included the following:

- a. Attending to the Estate administration, custody of the Estate's assets and obligations of the Estate;
- b. Continued handling approximately 6,000 pages of documents from Co-Personal Representative (provided per the Court's February 18, 2014 Order to deliver file to Curator), and response to document request and review of documents for privilege;
- c. Drafting motions, attending court hearings and motion practice before this Court seeking instructions with regard to the administration and issues raised in connection with same, including without limitation, tangible personal property, jewelry, IRA, resolving issue of successor personal representative, matters to be heard and order of hearings in July;
- d. Communicating with counsel and interested persons regarding pending litigation in Florida (Case No. 502012CA013933 (Circuit Court, Palm Beach County, FL) and Illinois (Case No. 13CV3643 (U.S. Dist. Ct. Northern District Illinois) involving the Estate and its purported assets;
- e. Preparing for and attending mediation for Stansbury law suit action; attention to settlement and representation issues;
- f. Communicating with and providing information to various interested persons, as set forth in the Curator's invoice; and
- g. Such other tasks as are set forth in the invoice.

WHEREFORE, Benjamin P. Brown, Esq., as Curator, respectfully requests that this Court enter an order awarding Curator a reasonable fee for services and expenses incurred, and authorizing and directing the Curator to pay such fees and expenses of the Curator from the assets of the estate.
