

“My name is BARBARA STONE. I am a Florida resident of Broward County, whose mother, HELEN STONE is in guardianship and being abused, neglected, and exploited. I have personal knowledge of the facts stated herein and attest that they are true and correct under oath. I hereby certify that I received emails from Roy Lustig, proposing a scheduling order; however, my email account was hacked for which a complaint has being filed with the FBI and is under investigation. I did not receive notice of the May 5, 2015 teleconference with the Magistrate or any other Judge. Roy Lustig did not contact me regarding any such conference either. I contacted Judge Lenard’s deputy, Patricia Mitchell yesterday afternoon and requested a copy of any Orders and she sent me a copy of the teleconference order which I learned of for the first time.

I have not been receiving automatic electronic notifications through PACER and am in the process of setting up electronic service. The only means I have had to obtain information on the case is mail, which has likewise not revealed any notice of teleconference with the Magistrate. I am going through the process of hiring an attorney admitted to the Southern District Federal Court of Florida and my understanding is that she uses PACER, so I do not believe this will not ever occur again and apologize.
