Jose Estrada and Rene Byron Brizuela claim Toyota and Saatchi & Saatchi violated copyright on their tune, "La Bomba" (sic - not the famous Richie Valens tune) in Los Angeles Federal Court.

#### Liability

Covington County Schools allowed a man take an elementary school student from school and rape her on six occasions, though he is unrelated to her and not unauthorized to take her from class, and on one occasion identified himself as her "mother," according to a complaint in Hattiesburg, Miss., Federal Court.

## Employment

Menzies Aviation Group, Evergreen International Airlines, Ironwood Management, and Swissport USA violate the Labor Code, according to class actions in Los Angeles Superior Court.

Class-action complaints alleging Labor Code violations also have been filed against these defendants: Verizon Northwest, in King County Court, Seattle; Fireside Bank, in Sacramento Superior Court; Chasing Unlimited/National Creditors Connection, and Volt Management/Volt Information Services, in Orange County Court, Calif.; Uncle Jack's Steakhouse Inc., in Manhattan Federal Court; Bio-Medical Applications of Florida/Fresenius Medical Care Holdings/National Medical Care, in West Palm Beach Federal Court; and Uni Taxi Service, in Gainesville, Ga., Federal Court.
