Comes now Julia M. Gonzalez, Appellant pro se, who respectfully prays and moves this Court as follows:

1. I am the Appellant pro se and provide Notice to this Court of my US Bankruptcy Case filing on Sept. 19m 2016 a true copy of which is attached as Exhibit 1.

5. My Bankruptcy attorney Chad T. Van Horn provided Notice of the Bankruptcy filing to ongoing cases in the 15th Judicial Circuit Courts ( lower courts ) but has been very busy and not able to give me a clear indication of whether such federal US Bankruptcy Stay also applies to proceedings before this Court.
6. Because I am seeking to take absolutely no action which would waive or compromise the Bankruptcy stay I am giving Notice to this Court of the filing and because the related appeal proceedings involve matters relating collection and taking of property and debts believe the Stay applies or may apply and thus take no action in this Court at this time.
7. This Court issued an Order on Sept. 14, 2016 before my Bankruptcy filing providing me 15 days to file a conformed copy of the Order being appealed with this Court. The 15 days is due tomorrow, Sept. 29, 2016 and I need more time to obtain the Order and file.
8. There is merit to my appeal and I believe the federal Bankruptcy Stay may apply and otherwise need an extension of time if this Stay is not in effect due to various meetings and efforts with my Bankruptcy attorney and other actions to protect my Homestead property protected by the Florida Constitution.

WHEREFORE, I respectfully pray for an Order staying these matters under the US Bankruptcy laws or if it is determined the Bankruptcy stay does not apply, then alternatively granting a reasonable extension of time to move before this Court to show cause why the Appeal should not be dismissed and rehear this Court's prior Order and file a brief and otherwise prosecute this appeal and such other and further relief as may be just and proper.
