# TRUSTEE'S OBJECTION TO NOTICE OF PRODUCTION FROM NON-PARTY

Ted S. Bernstein, Successor Trustee of the Simon Bernstein Amended and Restated Trust Agreement dated July 25, 2012 ("Trustee"), pursuant to Fla. R. Civ. P. 1.410, files his Objection to William E. Stansbury's Subpoena Duces Tecum Without Deposition.

1. On January 23, 2017, William E. Stansbury ("Stansbury"), filed his Notice of Production from Non-Party to All Regency Title Company d/b/a US Title of Florida ("US Title"), and attached a Subpoena Duces Tecum without Deposition to US Title (the "Subpoena"). A copy of the Subpoena is attached as Exhibit "A."

Trustee objects to the Subpoena because the Subpoena purports to seek documents and information which are: (1) not relevant nor reasonably calculated to lead to admissible evidence;
(2) address an issue which has been resolved by a court order, with no objection from Stansbury, and Stansbury did not appeal that order; (3) the discovery is intrusive into the rights of an innocent thirdparty, is unduly burdensome, and designed to harass the Trustee and the buyer.

3. In addition, clearly Stansbury lacks standing to seek this information in the Shirley Bernstein Trust, and to the extent that there is any relation to the Simon Bernstein Estate, the total dollar value of all personal property in the Aragon Condominium was fully accounted for, and paid for by the Shirley Bernstein Trust, as reflected in the order which Stansbury did not contest or appeal.

WHEREFORE, Trustee requests that this Court sustain his objection, prohibiting Stansbury from obtaining the issuance of the Subpoena to US Title, and any other relief this Court deems appropriate.
