THIS MATTER came before the Court concerning a Summary Judgment hearing set for 9:30 a.m. on February 21, 2017. Based on the information contained in this order, the agreement of the parties, and the Court being otherwise fully advised, does hereby

ORDER and ADJUDGE as follows:

1. The Court is advised by the parties that there is a pending issue of disqualification of Estate's counsel, which was set for hearing on February 16, 2017 before Judge Rosemarie Scher in probate court. The hearing did not conclude and will resume on March 2, 2017.

2. At the conclusion of that hearing, Judge Scher and the parties discussed the Summary Judgment hearing, and all parties believe the hearing should be continued until after the disqualification issue is decided.

3. Accordingly, the hearing set on the Estate of Simon Bernstein's *Motion for Partial Summary Judgment on all Claims for Fraudulent Transfer, Constructive Trust, Equitable Lien, and Other Relief Against the Estate Relating to Bernstein Family Realty, LLC and for Dismissal*

with Prejudice of all Claims Against BFR for February 21, 2017 at 9:30 a.m. is hereby cancelled and

may be rescheduled by either party at a later date.
