
THIS CAUSE came before the Court on May 18, 2017 on Ted Bernstein's *Motion to Approve Compromise and Settlement etc.* ("the Motion"). The Court, having reviewed the Motion and the record, and having been advised that no one else <sup>with standing</sup> objected to the Motion or this proposed Order, and being otherwise fully advised in the premises, hereby ORDERS AND ADJUDGES:

1. The Motion is GRANTED in part as set forth below, and DEFERRED in part pending further orders and/or hearings.

2. After mediation, a written Mediation Settlement Agreement ("Settlement") was executed by and between: (i) Ted S. Bernstein, as Trustee of the Simon L. Bernstein Trust (the "Simon Trust"), which is the sole beneficiary of this Estate; and (ii) the trustees of ten trusts created for the benefit of Simon's ten grandchildren under the terms of Simon's Trust, being all of beneficiaries and potential beneficiaries of the Simon Trust.<sup>1</sup>

3. The Settlement is approved and made effective immediately, subject to the terms of the Settlement. The Court will retain jurisdiction to enforce and fully implement the Settlement.

4. The Hon. John L. Phillips previously entered a Final Judgment on Count II and dismissed the counterclaim filed by Eliot Bernstein. The Settlement resolves all remaining issues raised in the Amended Complaint, including those set forth in Count I, other than the enforcement and implementation of the settlement, and the compensation and discharge of the Guardian.

5. The Court ~~determines that~~ <sup>retains jurisdiction to determine</sup> an appropriate hourly rate for the service of the Guardian ~~is \$~~ <sup>is \$</sup> ~~\_\_\_\_\_~~ and will enter a separate order determining compensation owed to the Guardian after hearing.



The Court retains jurisdiction to select and appoint a trustee to serve as trustee for the Eliot Children Trusts and/or to take further action with respect to these trusts. The order appointing a trustee for each of the Eliot Children Trusts will include a provision discharging the Guardian.

7. The Court retains jurisdiction to enforce and implement the settlement, determine the compensation and discharge of the Guardian, to appoint a trustee for the Eliot Children Trusts, and to address any related issues concerning the administration of the Trust.



including the Guardian. In the absence of unanimous agreement within 30 days from the date of this Order, the Court will appoint an independent person or entity to serve as Trustee of the Eliot Children Trusts, who shall utilize the trust funds solely in the best interests of Eliot's Children. The Court retains jurisdiction to select and appoint a trustee to serve as trustee for the Eliot Children Trusts and/or to take further action with respect to these trusts. The order appointing a trustee for each of the Eliot Children Trusts will include a provision discharging the Guardian.

7. The Court retains jurisdiction to enforce and implement the settlement, determine the compensation and discharge of the Guardian, to appoint a trustee for the Eliot Children Trusts, and to address any related issues concerning the administration of the Trust.
