**PETITION FOR ORDER AUTHORIZING SUCCESSOR
PERSONAL REPRESENTATIVE TO PAY FOR SERVICES OF CPA**

BRIAN M. O'CONNELL, as Successor Personal Representative of the Estate of Simon L. Bernstein ("Successor Personal Representative" and/or "Estate"), hereby moves this Court for an order authorizing him to pay for services of the CPA retained by the Estate, and as grounds therefore, would state as follows:

1. On June 24, 2014, Mr. O'Connell was appointed as the Successor Personal Representative of the Estate of Simon L. Bernstein ("Estate" and "Decedent", respectively).



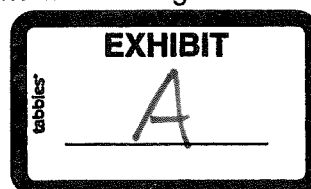
