AMENDED MOTION TO DIRECT PAYMENT FOR BENEFIT OF ELIOT IVAN BERNSTEIN BE PAID INTO COURT REGISTRY

COMES NOW, Brian M. O'Connell, Esq., as Successor Personal Representative of the Estate of Simon L. Bernstein ("Successor Personal Representative," and "Estate," respectively), by and through undersigned counsel, and hereby moves this Court to direct payment for the benefit of Eliot Ivan Bernstein be paid into the Court Registry, and in support thereof, states as follows:

1. On October 26, 2018, O'Connell & Crispin Ackal, PLLC, counsel for the Successor Personal Representative, sent a letter to Mr. Eliot Ivan Bernstein, 2753 N.W. 34th Street, Boca Raton, FL 33434 ("Eliot"), which enclosed the distribution check from the Estate payable to him in the amount of \$16,667.60, Check No. 1008.

2. Eliot did not cash the check or respond to the letter.¹

3. On July 24, 2019, O'Connell & Crispin Ackal, PLLC, sent another letter to Eliot, which enclosed the distribution check from the Estate payable to him in the amount of \$19,159.00, Check No. 1018. See letter attached hereto as Exhibit "A".

4. Such amount, \$19,159.00, was Eliot's full and final distribution from the Estate of his share of the proceeds from the sale of the Decedent's, Simon L. Bernstein ("Decedent"), tangible personal property, including the Decedent's jewelry.

5. Given Eliot's prior litigation conduct, in the event the check is not cashed by August 12, 2019, as requested in the second letter, it is evident that any further attempts to contact Eliot would be futile, and the most cost-effective solution is to transfer the \$19,159.00 payable to Eliot into the Court Registry.

6. While there may be some fees charged by the Clerk of Court, any such fees will be minimal in comparison to the cost of attorneys' fees for continued attempts to contact Eliot.

7. Accordingly, the Successor Personal Representative requests the Court direct that the payment of \$19,159.00 to or for the benefit of Eliot be paid into the Court Registry, as this is in the best interest of the Estate, and to avoid further expense.

WHEREFORE, Brian M. O'Connell, Esq., as Successor Personal Representative of the Estate of Simon L. Bernstein, respectfully requests the Court enter its order directing the payment of \$19,159.00 to or for the benefit of Eliot Ivan Bernstein be paid into the Court Registry, as further stated herein, and for any such further relief deemed just and proper by this Court.
