Dear President Barack Obama and US Attorney General Eric Holder:

I am now personally bringing it to your President's attention that I have repeatedly filed with US Attorneys Eric Holder, Preet Bharara, Governor Cuomo, NY Attorney Gen. Eric Schneiderman, NY DA Cyrus Vance that Bernard Madoff (LES/NYC NY) and Morton Madoff (Boston) thru Emily Madoff/Wolf Popper acted with Assembly Speaker Sheldon Silver and Surrogate Renee Roth, John Fisher and Harvey Corn to steal from estates including but not limited to Simon Goldberg Estate and Evelyn Goldberg Estate and launder the money thru Emily's List and NY Political Campaign funds including but not limited to Alfonse D'Amato, Charles Schumer, Clinton, Gillibrand and Carolyn Maloney. Fraudulent Guardian-ad-litem, trusteeships and appointments were openly reported to the SDNY/EDNY US Attorney's Office, Mooreland Commission, NY/Brooklyn DA's office. At no time did US Atty Preet Bharara, NY AG Schneiderman, DA Vance, NY State Disciplinary Committee act to investigate, follow up or pursue what was a NY State-wide Surrogate Court Ponzi Thefts Scheme beginning as early as 1985 progressing to 1993 and ballooning to 2015 with funds laundered thru election campaigns.

I am now asking you, Mr. President, Barack Obama, to personally address the looting of NY and MA Estates that began with Father Drinan, Barney Frank, Barbara Boxer and moved to Patrick Leahy and John Kerry via Mary Beth Cahill, Ellen Malcolm and the original Emily's List Founders Clinton, Shalala, Mikulski and others.

In 1993, Evelyn Goldberg reported the Madoff Scheme. In 2008 as Executor, I followed with Ex Parte Backroom Conversations proof of Madoff, Surrogate Roth, Fisher and Corn, and now 2014 billing statements. I have been threatened: (1) openly in Surrogate Court, (2) with stolen Bank of America accounts that disappeared, (3) Illinois House Speaker Michael Madigan stopped Telephone Harassment, and now Blacklisted by NY State First Department from Bar Admission by Charles Moerdler of Stroock & Stroosck.

In 1998, I reported directly to **Hillary Clinton** and Al Gore that: over 100,000+ Inner City Children had been failed by McGraw Hill; 10,000 Phantom Teachers were listed on State Rosters with the United Federation of Teachers; no text books; and that Martin Luther King Jr. H.S. behind Lincoln Center was full of Pedophiles. Justices John Roberts and Sonia Sotomayor in two different cases both acted individually in the cover up. Evelyn Goldberg, not only witnessed these frauds and documented them, she attended my bogus bar hearings.

On March 27, 2015 as Executor for Evelyn Goldberg Estate, I am appearing before Surrogate Nora Anderson for a petition demanding an accounting of the Simon Goldberg Estate that was plundered by Fisher and Roth. Evelyn Goldberg brought a Federal Civil Rico case that **Judge Duffy** took from Judge Barbara Jones who while as Manhattan ADA under Morgenthau covered up the Madoff ponzi scheme. Fisher and Judith Siegel Baum both swore affidavits there were no ex parte conversations with Roth while Siegel Baum billed for them. The **New York Times** had at all times the evidence and chose to suppress Madoff Ponzi Emily's List Scheme.

Evelyn Goldberg personally witnessed NY State Attorneys and NYC Corporation Counsel hiding evidence of **Justice John Roberts/Daniel Keating of Hogan & Hartson** ownership of the New Teachers Project that hired me to teach Chemistry then fired me when Vicki Bernstein (Boston) identified me as the whistle blower for 100,000+ students failed that passed. BOE Director Thompson ordered Bernstein to resolve the failings in 1998. **SDNY Judge Chin** intentionally covered up the 2/16/01 email to Karla Oakely (3<sup>rd</sup> Party Robert's employee) and 4:59 PM Email from Chad Vignola's Office to his Staff Attorney and Bernstein to fire me. Evelyn Goldberg then witnessed State AG's office lying that CUNY RF was in illegal contracts with Justice Roberts. **Judge Chin** also covered up **Norma Ramirez's SDNY lawsuit** against Gouverneur Hospital by covering up the **1973 Mayor Lindsay NYC Bailout Contract** that guaranteed Ramirez her title and employee rights. Sheldon Silver's cousin, Haggler ran the Hospital and at all times **Rep Carolyn Maloney** did nothing.

Evelyn Goldberg personally witnessed SDNY Judge Michael Mukasey and Charles Moerdler shielding Giuliani for his 2004 Presidential Run from Pedophiles, False Failing and No Text Books at MLK HS scandals. **Justice Sonia Sotomayor** was recorded on the bench with **Cardamone** calling me a "Miserable Fag" while Judge Katzmman was wired from the backroom. The Federal Docket was altered for Sotomayors application and Senator Leahy's Chief of Staff Edward Pagano sanitized her federal hearings to the Supreme Court. Judge Cardamone recused himself because of his family relationship to John Feerick who blacklisted me below. **Northrop Grumman's MLK HS Representative-After school Teacher Rebecca Fabiano**, a pedophile, had sex with Mustapha Jatta, 42 times during school. I was responsible as designated parent for Mustapha Jatta. **Judge Katzmman** recused himself as a Fordham Law School State Licensing Review Member for almost a decade of reviews that were never filed with the NY State Government and American Bar Association. **Judge Mukasey** and Judge Chin communicated to NYS Character & Fitness Committee to stop my bar entry.

Evelyn Goldberg personally witnessed with Karen Dunn, **Charles Moerdler's** verbal attack on Loren during his administrative character hearing when Loren called for **SDNY Judge Batts** to be called as a witness that Hughes Hubbard & Reed, **Robert B. Fiske, Jr.** and **Wayne Warnken** called Fordham's Dean **John Feerick** and Assistant Dean **Georgina Vairo** to threaten me from pursuing my farm ownership documents in Hughes Hubbard and Reed's possession. **Deborah Batts** got me the information after I went to all my teachers about the threat and then turned around and got a judgeship, then sat on my case as judge, witness, and executioner. Moerdler also went after me for exposing **SDNY Judge Kimba Wood** fixing her divorce case against Nancy Richardson who didn't know she had the same law firm until I told her. I met with Raoul Felder & Richardson. I have never been allowed to appeal my administrative hearing denying my bar application and am listed as anonymous. Most if not all decisions about me in SDNY courts are non-publishable and kept off the record.

Therefore, Mr. President, on behalf of the hundred's of thousands of children of NYC who were failed that actually passed, on behalf of the hundred's of estates that were looted by Sheldon Silver and Renee Roth, on behalf of the children preyed on by Pedophiles in Martin Luther King Jr. High School and at Lincoln Center, I am asking you, Mr. President, Barack Obama, to request that US Attorney Eric Holder address the gross injustices to the Evelyn Goldberg Estate by formally investigating the Madoff Surrogate Ponzi Scheme, the Blakely v. Wells action filed on behalf of the Students of Martin Luther King Jr. HS now before Preska and whistle blowing case now before Judge Preska known as Loren v. Levy. Thank you for your consideration.
