**DECLARATION TO ILLINOIS SUPREME COURT  
TO ALLOW JOANNE DENISON TO

1. My name is Eliot Ivan Bernstein and my address is 2753 NW 34<sup>th</sup> St., Boca Raton, FL 33434, and this is in regard to the ARDC's current mission to take away the law license of Attorney Joanne Denison ("Ms. Denison") for merely running a blog that tells the truth about the fraud on the court and the lack of respect for the US and State Constitutions and the Illinois Probate Act in and without the Illinois Probate System.
2. I am very familiar with Ms. Denison's blog and have read about 20 posts on it.
3. I have read the complaint in Ms. Denison's case and am familiar with it. I understand that Ms. Denison is under an interim suspension because she blogs about corruption in Probate. I believe it is wrong to go after someone who exposes only the truth. I have read the blog and Ms. Denison's blog is extremely helpful to Probate Victims and their families. I am very familiar with her work, and she does in fact tell the truth.



Without her, her I would not have any representation. Prior to using Ms. Denison, I had sought help from approx 20+ attorneys and paid \$30,000.00 all to no avail in my case. I have now tried to find low cost legal assistance in Probate and I can find no one.
5. I understand Ms. Denison is now suspended. I have been left without counsel and I believe and demand that indigent and lower middle class clients should have representation in Probate.
6. I am petitioning the Illinois Supreme Court to allow Ms. Denison to represent lower income and indigent clients, including myself, because without her, we would have no attorney to represent us. I am now left without an attorney to represent me, and I believe that I deserve representation even though I cannot pay large retainers and large fees to attorneys. My case is important too.

Ms. Denison is obligated to report misconduct of attorneys at law by her Il Bar Rules and by reporting such she is doing a service to her profession and the public at large and should be able to speak openly and publically about the misconduct she witnesses as an attorney, without fear of retribution or disbarment for her efforts.
