

# Assets Controlled by U.S Elderly




#### Demographics

- \$1.5 trillion transfers generationally each year today, grows to \$2.5 trillion by 2025
- 65+ head of household average net worth \$600,000
- 75+ head of household average net worth \$300,000
- Conservatorship and Probate court intervention can divert all to unintended third parties

## How many Americans are affected?




#### **Demographics\***

- 0.5 % of population or 1.3 million adults under guardianship.
- $\approx$  180,000 adult guardianships added in 2016.
- Adult guardianships growing at 10% plus per year.

## U.S. Vulnerable Elder Population Growth



Alzheimer's, and other dementia, often make elder financial exploitation a lucrative **and voiceless** crime.

# <u>The Basics</u>

Guardianship....the removal of all rights, decision making ability, and estate.

Granted to a third party by order of the court. "The Warden".

Alleged incapacitated persons (AIP) who are placed into guardianship are referred

to as "wards".

All court appointed parties fees paid for by the ward's estate.


Guardians provided "quasi" immunity by the appointing judicial officer.

## <u>Types of guardianship</u>

- Conservatorship-Designated as a "conserver" of the estate for the ward, same as guardian of the estate.
- Plenary or General Guardianship-Guardian of Person and Estate.
- Guardian of the person controls rights of association, medical, residence, and travel.
- Limited Guardianship-Plenary Guardianship with limited rights.
  - Voting rights often maintained to preclude federal violations.







Family "dysfunction" is the time tested successful litigation strategy, suspect exploiters often defended by court allies

#### What families expect....

- Protect estate documents
- Protect the alleged incapacitated person
- Protect the family
- Uphold state and federal laws
- Conserve the estate, especially trusts
- Insure guardian accountability

#### What attorneys know....

- Professional conservatorship is the priority
- "Story telling" embraced
- Estate documents routinely denied
- Defame the legitimate trustees
- Legitimize non-designated "blacksheep"
- Litigation is extended beyond death

"I'm an officer of the court whereas...You sir, don't know much about fiduciary situations. As a general rule, it is poor planning to have one sibling a fiduciary for another sibling or one sibling a fiduciary for multiple siblings after the death or substantial incapacity of a parent. Sir, if you knew anything at all about human nature, you would realize that upon the death of both parents or the significant incapacity of both parents, family dysfunctions rise. #### Common trademarks: isolate the ward, defame the family, liquidate the estate

#### **Top Red Flags of Fraudulent Guardianships**

- Petition for Appointment of Guardianship
  - Justification
  - *Medical evidence...how obtained...how complete*
  - Estate documents
  - Assets
  - Recognition or Defamation of executor
  - Exhibits to support
- Guardianship Order
  - Issue date versus initial hearing
- Objection to the Petition for Guardianship
  - Claims and Evidence
- Initial Hearing
  - Notice, minutes and recording
  - Alleged Incapacitated Person, testimony
- Initial Inventory
  - Timing and Completeness
  - Bank Statements
- <u>Annual Accountings</u>
  - Timing and Completeness
  - Bank Statements and reciepts

#### Department of Justice Civil Division inquiring...

Involuntary guardianships designate the alleged incapacitated person "disabled". Federal Americans with Disabilities Act of 1993 and the Olmstead Act provision enacted in 1999. Most adjudicating courts ignore federal obligations.

- INVOLUNTARILY placed into guardianship and advance directives or state law denied
- INVOLUNTARILY INSTITUTIONALIZED AND ISOLATED. (Olmstead Act Violations)
- Collaborating with each state protection and advocacy group. (DHHS funded) to defend AIPs.

#### **Federal Elder Abuse Prevention and Prosecution Act**

- President Trump signed into law on October 18, 2017
- "Elder Justice Czar" to be appointed by DOJ in 2017. Appointee for each federal judicial district (94)
- Increased funding for training of law enforcement and prosecutorial resources on elder abuse.
- Specifically reinforces Power of Attorney, Conservators, and Guardians have no immunities to criminal investigations.

Federal engagement hopefully will address egregious state and local issues.

#### Continue to Communicate the Issues with Leadership

• Executive, legislative, judicial, prosecutorial, and law enforcement.

#### Define the Risks

- \$1.5 trillion a year industry can't be managed on the honor system
- Law Enforcement and criminal prosecutorial oversight required

#### Needed Adult Guardianship Reforms in California

- Insure courtroom compliance with all federal and state laws during adjudication
- Third party financial auditing and investigative authorities established; Minnesota model.
- License and bond all guardians; no exceptions
- Law enforcement integration to insure criminal complaints are investigated or dismissed
- Statewide ward registry and asset tracking; transparency
- Designated state guardianship investigation board to field all complaints






