ORDER TO SHOW CAUSE

THIS CAUSE came before this Court on April 3, 2017 on Petitioner's Expedited Motion for an Order to Show Cause Why the Court Should Not Issue a Writ of Bodily Attachment against the Respondent, which alleges that Respondent has failed to comply with the Final Judgment of Dissolution entered on August 5, 2013 [D.E. 181], this Court's Order of May 3, 2016 on Petitioner's Renewed Motion for Enforcement and Motion for Contempt [D.E. 258], and the Order of Contempt entered on June 16, 2016 [D.E. 285]. The Respondent did not appear, although duly noticed by this Court's Order setting the hearing. This Court has reviewed the court file, heard argument of counsel and is otherwise fully advised in the premises. Based on the foregoing, it is hereby;

ORDERED AND ADJUDGED that Respondent shall appear before this Court on Friday, April 21, 2017, at 1:30 p.m. in Courtroom 2, at 200 W. Atlantic Ave., Delray Beach, FL 33444, to show cause, if any, why Respondent should not be adjudged in further civil contempt of Court and/or a writ of bodily attachment issued for Respondent's incarceration for Respondent's willful and contumacious failure to comply with the Final Judgment of Dissolution

entered on August 5, 2013, this Court's Order of May 3, 2016 on Petitioner's Renewed Motion for Enforcement and Motion for Contempt, and the Order of Contempt entered on June 16, 2016. More specifically, her failure to comply with Paragraph 9 of the Final Judgment of Dissolution, Paragraph 3 of this Court's Order of May 3, 2016, and Paragraph 5 of the Order of Contempt, which directs that "Respondent shall thereafter fully comply with the Final Judgment of Dissolution and shall not hinder in any manner the sale of the Property."

Respondent has filed three separate new lawsuits against Petitioner, his attorney, his attorney's law firm and the receiver, one in Palm Beach County, case no. 50-2017-CA-003589-XXXX-MB; Broward County case no. CACE17005848 and a *Lis Pendens* filed in the same case; and a third case in Broward County which has not been assigned a number, all attached as Exhibits to Petitioner's Expedited Motion.

Respondent is directed to show the Court why the filing of these lawsuits is not in violation of the Orders set forth above and subjecting Respondent to the issuance of a third order of contempt and/or a writ of bodily attachment for her incarceration, with the purge for her contempt being the voluntary dismissal, with prejudice, of all three lawsuits, including a dissolution of the *lis pendens*. If Respondent does not appear or does not show good cause, this Court may hold Respondent in civil Contempt of Court, the sanctions for which may include, but are not limited to, monetary fine and arrest by the issuance of a Writ of Bodily Attachment.

FURTHER ORDERED AND ADJUDGED that Respondent **SHALL APPEAR AT THE HEARING IN PERSON**, and not via telephone.

FURTHER ORDERED AND ADJUDGED that due to Respondent's failure to update the Court with her current physical address, service of this Order may be made via e-mail.

FURTHER ORDERED AND ADJUDGED that this Court shall reserve jurisdiction to determine sanctions, including attorney's fees, to be imposed against Respondent.
