ORDER DENYING RESPONDENT'S MOTIONS

THIS CAUSE came before the Court on March 28, 2017, upon the following Motions:

1. Respondent's "Motion For: To Vacate/Set Aside Illegal Writ of Possession of Homesteaded Property, Issued 12/22/2016 and Illegally Executed on 01/04/2017, Vacate Order For Contempt of Court and Vacate Final Judgment Based on Fraud Upon the Court. To Set Hearing Date to Set Aside" [D.E. 353];
2. Petitioner's Response to Respondent's Motions to Vacate and Motion to Strike and Sanction Respondent [D.E. 357];
3. Respondent's "Demand Letter to 'Cease and Desist' From Fraudulent Possession and Sale of my Homesteaded Property, Located at 17103 SW 39th Court Miramar FL. in Broward County" [D.E. 360]; and
4. "Respondent Julie Gonzalez, Request Motion for Stay Pending Previous Motion Filed to Vacate Illegal Writ of Possession Order Based on Fraud Upon the Court and Previous Motion to Schedule Hearing Date." [D.E. 361];

and the undersigned Judge, having reviewed the file, having heard argument of counsel, and being otherwise fully advised in the premises herein, it is,

ORDERED AND ADJUDGED as follows:

1. The Court finds that Respondent was duly noticed of today's hearing by counsel for the Petitioner [D.E. 369]. Respondent did not attend the hearing.

2. Respondent's Motions set forth above [D.E. 353, 360 and 361], and Respondent's "Motion for: Vacate or Set Aside" [D.E. 346] are hereby **DENIED**.

3. The Court notes that Respondent has already filed an emergency motion addressing matters heard at the March 28, 2017 UMC and seeking reconsideration thereof, which emergency motion the Court has set for hearing on April 3, 2017 at 3:00 p.m. This order is without prejudice to Respondent to attempt to establish a basis for rehearing at the foregoing scheduled hearing upon demonstration of excusable neglect and good cause for her failure to attend the March 29, 2017 hearing after having been properly noticed thereof.
