- 1. **Penalty Mail**: Official mail sent without postage prepayment by officers of the executive and judicial branches of the U.S. government, by departments and agencies of the U.S. Government and by specifically authorized individuals. Agencies then reimburse USPS for the penalty mail service they receive. USPS requires agencies to use penalty postage meters or other forms of direct accountability for proper reimbursement through the Official Mail Accounting System. The term comes from the endorsement "Penalty for Private Use" printed on the mail.
- 2. GROUP OO: Special designs used only by the federal government to frank official business mail. All Official stamp designs have a matching commercial meter stamp design. The Official stamps are sub-grouped accordingly. All franks include OFFICIAL MAIL and a "penalty for private use" statement somewhere in the design. The earliest use of a government official business meter was in 1974.

- 3. I received two sets of letters allegedly from the United States Court of Appeals For the Seventh Circuit, 219 S. Dearborn Street, Chicago, Illinois 60604-1874 the words "Official Business" and NOT "US Official Mail Penalty for Private Use \$300" are imprinted on the envelope.
- 4. Both envelopes have the same counterfeit Pitney and Bowes metered stamps device ID number 0000886189 OCT 18 2019 EXHIBIT 1, DEC 09 2019 EXHIBIT 2 which is an ID number that does NOT exist. Obviously, because a fraudulent device ID number was used; a permit number was NEVER obtained from the US post office. Therefore, payment was not received by the post office. On information and belief the genesis believe that using counterfeit meter stamps to send counterfeit and fraudulent documents through the United States mail absolves them of mail fraud and a host of other felonies that a honest grand jury would indict them for. The only trick here is to find a group of law enforcement officials that does not take bribes.
- 5. Notice that the print head design that is used by: United States Court of Appeals For the Seventh Circuit, the Judicial Inquiry Board, Anselmo Lindberg Oliver, Roberts & Weddle, LLC, Fifth Third Bank, etc. all contain the print head design from year 2002.
- 6. On the newer print head designs the words "PITNEY BOWES" (preceded by three stars and ends with three stars) is curved around Eagle's head at top. The design used by the alleged fraudsters have the words "UNITED STATES POSTAGE are over the Eagle's head. The designed used is from the Pitney Bowes "DM100-400, DM300-400, DM550-1100, MailStation 2" (digital), 2002 series. The words "PITNEY BOWES" does not contain the same art deco print that is found on the official but older stamp. On closer inspection the main font is also different from the legitimate font. Most go through the three letter "604" system.

As already discuss in other videos no attorney can legally file documents with the court using a variation of their registered name. Similarity no judge has the authority to hear a case if he or she engaged in the same criminal act.

PUT METER STAMP REGIS REQMENTS.

U.S. Postal regulations prevents any fraudulent documents to be mailed through the U.S. mail

Therefore, in furtherance of the scheme, counterfeit Pitney & Bowes, Neopost meter stamps are used to mail these fraudulent documents. Of course I reported to the U.S. Postoffice, several times and they did nothing about it.

- 7. A commercial mail receiving agency (CMRA) is a private business that accepts mail from the Postal Service on behalf of third parties. A CMRA may also be known as a mail drop. A customer of a CMRA can receive mail and other deliveries at the street address of the CMRA rather than the customer's own street address. Depending on the agreement between the customer and the CMRA, the CMRA can forward the mail to the customer or hold it for pickup. Unlike a post office box, a CMRA operates independently of the national postal administration and is therefore able to receive courier packages or other non-mail. CMRAs typically provide ancillary services such as facsimile, copy or courier.
- 8. Financial institutions are prohibited by law from using a CMRA. Therefore, the fact that I am receiving mail from numerous CMRAs' and that Shellpoint and the other banks uses so many different addresses serves as a red flag.

2.1.4 Physical Barcode Requirements. I will focus on one of the requirements for now. You can see

Barcode Height: unless allowed by exception, the minimum height must be at least 0.75 inch. You can see that all the even close to ¾ of an inch. Further Bar code. ADD PLACEMENT OF BAR CODES.

Look closely you can see that the counterfeit bar code are usually consists of a white sticker label that is placed in locations where the scanner is designed to read them such as at the top or the very bottom of the envelope.

Keep those envelopes!
