### Comments:

Dear Sheriff Hohenstein, thank you for your time on the phone and assuring me that Mr. Simpson would be put in protective custody and no harm would come to him under your watch! I have attached several correspondences including those to Judge Garaventa, the RBPd and finally Lonnie Davis of the Inspector General of the United States Department of Justice's Glenn Fine's office. I hope that these letters shine some light on the other possible collateral issues we spoke of in regard to Mr. Simpson beyond the attempted murder and stabbing by Joey Davis and the possible links to white supremacist groups. These other matters are currently under a host of federal, state and international investigations and currently are before The Honorable Shira A. Scheindlin of United States District Court ~ Southern District of New York. I will instantly be contacting all those investigators of these matters of your involvement and assurances of Mr. Simpson's safety while in your custody.

Again, I appreciate your efforts on Lucas' behalf and if you need additional information please feel free to contact me. I am also requesting that you contact immediately if possible, Judge Garaventa regarding any possible orders he could issue to further insure Mr. Simpson's safety while these matters are ongoing.

Dear Honorable Judge Garaventa,


In regard to the January 21, 2008 letter sent by my brother-in-law Lucas Simpson and the danger his life may be in regarding his outstanding traffic infarctions and willingness to settle them with your Court, I am writing to inform you that inapposite of his pleas for his life regarding these matters, he was arrested and incarcerated at Red Bluff Police Department and put in with the general population. As you are aware, Mr. Simpson was stabbed repeatedly three times in an attempted murder by what appears to be a white supremacist group here in Red Bluff and a one Joey Davis, who may or may not be currently at the facility with Mr. Simpson.

We have contacted the authorities to have Mr. Simpson released in light of the danger and liability this may pose to both Mr. Simpson and the City of Red Bluff, in the event that he is murdered while incarcerated. He was told that he would be taken immediately to protective custody but this is not the case, he has been put in general population and thus every second poses severe risk to his life and all over some traffic fines? I have contacted Department of Justice officials at Inspector General Glenn Fines office who are investigating possibly related matters for my companies of what has been occurring and the possible tie in's to my situation. I would think it best that if you have

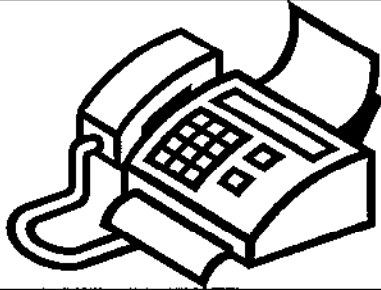



PLEASE DELIVER IMMEDIATELY TO LONNIE DAVIS

Lonnie, regarding the 1/21/08 letter regarding these matters, I would like to inform you that a group of no less than 4 Red Bluff police officers descended upon a home where Lucas Simpson was staying. Mr. Simpson was arrested for traffic warrants that were the subject of the letter I sent over last week and all are minor to say the least. Although Mr. Simpson upon arrest was promised that he would be put in protective custody, as the officers appeared fully aware of the attempted murder stabbing on him several weeks ago and in fact were involved in the follow up, he was put in general population, where many of the gang members are housed. This may prove fatal as the gang members have promised to harm him and it appears crazy that the police would endanger him knowing of the ongoing investigation into the stabbing, especially where these are traffic infarctions. Please have a copy of these matters immediately forwarded to the Office of Inspector General Glenn Fine's attention, as this may be an area for immediate oversight.

RE: Lucas Simpson Traffic Tickets and Stabbing

Dear Honorable Judge Garaventa,

I am writing to you in regard to my ticket disposition and asking that you expunge the tickets and fines in order to protect me from a very dangerous situation that could unfold in the event that I am arrested and brought to jail for these infractions. As you may know, on September 15, 2007 I was stabbed outside the Palomino Room by Joey Davis, Cody Boen and Jason Haynes, in an attempt to murder me for unknown reasons. I am unsure why these individuals have not been arrested or formally charged with the stabbing by local PD but in the interim, the risk of getting arrested for my traffic tickets would put me in extreme danger in jail, as they have vowed to get me, wherever I am. Many of their White Supremacist friends are in the jail at any given time and I am still unclear what has happened to Joey Davis, the main accused and if he has been released without being charged or has been transferred from the Tehama County Court House and charges are pending or being formulated.

I have had to uproot my family for several months in fear, with no police protections yet in place and this has caused my wife and children an extreme amount of emotional distress caused by loss of jobs (my wife had to quit for months and I am disabled from the stabbing), change of schools, extreme financial hardships, etc. Also, as you know, I was turning my life around and working in construction and doing well at the time of the stabbing but at the request of my medical doctors, I have been unable to return to my former line of work while the wounds may take up to a year or two to fully heal according to doctors. This has reeked financial havoc upon me and family, making the chance that I could even pay a minimal amount of my tickets impossible and this

leaves me in a Catch 22 that could find me in harms way if the police arrest me for these minor infarctions and I get sent to jail for even a minute while these people have clear intent to murder me. Thus, I beg your Honor to find a way that I can either be discharged of my obligations to pay the fines, removing any warrants that may have come about due to my lack of payment or find a way that I can work them off without going to typical community service programs, as many of the gang members are usually working on those same jobs, again this could lead to serious problems. I am unable to work at this moment and until the doctors remove me from the disabled condition they have listed me in and finish my physical therapy which could take another year or two, I do not see a reasonable way to pay the remaining balance on my tickets.

In closing, I am living in constant fear for my family, the people who stabbed me have not been formally charged and I am asking if you could also inquire into when and if the local PD are going to file formally charges against at minimum Joey Davis who was the main perpetrator who stabbed me thrice. I fear that they are going to allow him out and may have already, when he clearly intended to murder me and so stated at the time of the stabbing. I do not know why this gang wants to harm me, other than my wife, Crystal Simpson, testified against Charlie Abraham, leading to his incarceration and Joey Davis and others associated with him have said he acted on orders from "above". After stabbing me, while laying in a massive pool of blood, Davis stood over me and told me not to worry, I would be dead soon or words to that effect and then ran off to leave me for dead. I have given local PD all these facts and there were many witnesses who saw the crime and are willing to so testify.

Abraham has physically assaulted my children, trying to rip one out the car while my wife was driving and had stopped for a moment at a stop light. Abraham at that point threatened to kill her and the children and told her he would hunt them down and do sexually explicit things to her and the children. Crystal further reported this incidence to Red Bluff PD and his parole officer but nothing further happened until this stabbing. I have never had any dealings with Joey Davis other than to know of him and thus he had no reason to stab me other than because of his association with Abraham's group of Nazi Supremists. Joey Davis has not been charged, to the best of my knowledge with the

stabbing, although he appears to have been incarcerated for the last few weeks on other non-related charges. I am uncertain if I need to file a civil action for criminal investigators to formally charge him but again, testifying could pose severe risk to my family and people have actually called friends and family to warn them that I could be further harmed if I did, of course, this would not deter me from testifying as I feel that Joey Davis is a threat to all the people in Red Bluff. Nonetheless, I am pleading with you not only to help me on the traffic issues, I already appreciate all you have done to help me get those turned around without serving time but to help me determine how best to deal with getting Joey Davis and the others arrested for this heinous and unwarranted crime upon me. You may feel free to call upon me for any further information regarding these matters and I would be happy to appear before you if necessary.
